## AGENDA

**PLEDGE OF ALLEGIANCE TO THE FLAG:** Led by President Ramya Shaw.

Blank, Bradford, Camporeale, Gilbride, Hill, Salas, Wirz, Yeager and Zachary were absent/excused). A quorum was declared. (*\*After roll call, there were 34 members present and 6 members absent/excused, as Reps. Camporeale, Gilbride and Hill arrived after roll call.*)

**PRESENTATION:** Mary Lou Rinaldi, Chair of the Board of Finance, gave an introductory summary of the Board of Finance's transmittal of the additional tax rate to provide funds to a reserve account for capital non-recurring expenditures. Richard Freedman, Board of Finance, then gave a slide presentation with additional detail on the topic and a discussion period ensued.

Item 1 (F32.088)'s Resolution No. 4444 was read into the record by Fiscal Co-Chair Morson, and then moved (Morson), seconded (multiple) and after a brief discussion, approved via a roll call vote of 32-1-0 (Reps. Adams, Beckham, Bouchard, Boudreau, Camporeale, de la Cruz, Didelot, Dorsey, Field, Finkel, Gardner, Gilbride, Goldberg, Graham, Hill, Hughes, Hyatt, Johnson, Lapine, McKeown, Morson, Pelliccia, Pollack, Price, Sandford, Shaw, Shore, Stone, Sylvestre, Walston, Weathers and Weinberg approved; Rep. Pavia voted against; Rep. Gross left the meeting prior to the vote).

Prior to the meeting adjourning, Fiscal Co-Chair Morson thanked the members of the Fiscal Committee for their work this budget season.
