



Dear Colleagues:

For the past several months, one of our colleagues on the Stamford Board of Representatives, Marion McGarry, has published racially charged comments directed toward Muslims and Hispanics on social media. Examples of these comments are attached for your consideration. These public statements are outrageous from an elected member of our Board and cannot be tolerated. Accordingly, a Special Meeting has been called to Censure Representative McGarry for her actions.

As you are aware, our Board is governed by Robert's Rules of Order. Chapter XX of Robert's Rules provides that members "are required to be of honorable character and reputation" and, as such, members of our Board cannot violate the values that our organization holds dear. A member of our Board who violates those values deserves to be censured – that is, for a majority of our Board to publicly denounce such behavior through a resolution.

Stamford is a diverse community where neighbors, no matter their political beliefs, treat each other with decency and respect. An elected member of our Board endorsing racist comments outside of our meetings is a violation of those values and arguably deserves censure. The Special Meeting to Censure will determine whether we will live up to our values.
