RESOLUTION NO. 4455 AUTHORIZING THE MAYOR TO SUBMIT THE YEAR 52 ANNUAL ACTION PLAN FOR THE COMMUNITY DEVELOPMENT PROGRAM OF THE CITY OF STAMFORD, CONNECTICUT


WHEREAS, the City of Stamford, Connecticut is entitled to receive from the United States Department of Housing and Urban Development (HUD) NINE HUNDRED FORTY-FIVE THOUSAND, SIX HUNDRED TWENTY-FOUR DOLLARS (\$945,624) under the Community Development Block Grant (CDBG) Program and FOUR HUNDRED SIXTY-SIX THOUSAND ONE HUNDRED SEVENTY-ONE DOLLARS and THIRTY-SIX CENTS (\$466,171.36) for the HOME Investment Partnerships Program (HOME) for Federal Fiscal Year 2026; and

WHEREAS, these funds are subject to filing an Annual Action Plan with HUD and completion of all citizen participation requirements:

BE IT THEREFORE RESOLVED THAT the Mayor is hereby authorized to file with HUD an Annual Action Plan, incorporating the CDBG and HOME budgets for Program Year 52. The Mayor is further authorized to execute all related forms for the Community Development Program, including all understandings and assurances/certifications contained therein; and the Mayor is directed and authorized to act in connection with the 2025-2029 Consolidated Plan and related forms and execute all related contracts for the receipt of CDBG and HOME funds and to provide such additional information as may be required including reprogramming of existing Community Development funds and program income and further;

The above Resolution shall be effective upon enactment.
