PROPOSED ORDINANCE NO. __ ADOPTING A NEW FEE SCHEDULE FOR LAND USE APPLICATIONS

WHEREAS, Section 8-1c of the Connecticut General Statutes authorizes any municipality by ordinance to establish a schedule of reasonable fees for the processing of applications by a municipal zoning commission, planning commission, zoning board of appeals or inland wetlands commission; and

WHEREAS, the administrative costs of reviewing and processing the applications made to said commissions has increased significantly; and

WHEREAS, it has been determined that it is in the best interests of the City of Stamford to increase the fees for said applications to cover the higher costs.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF STAMFORD THAT:
