Operational Highlights

No changes are proposed in the programs, responsibilities or initiatives of the Land Use Bureau, which are largely defined by Charter and Ordinance. The Land Use Bureau will continue to provide support to the four land use boards (Planning, Zoning, EPB and ZBA) and to conduct park and open space planning, support the Sustainable Stamford Program, prepare a recommended Capital Budget, administer long range land use planning programs, enforce zoning regulations and review development proposals.

Major Activities and Highlights for 2014-2015 include the following:

- Citywide Master Plan Update completed December 2014
- Glenbrook/Springdale Transit Oriented Development Pilot Study on budget and scheduled to complete in the second quarter of 2015
- West Side Transportation Study on schedule and scheduled to complete in second quarter of 2015
- Capital Budget Planning 2015-16 budget completed within Charter timeline
- Major Development Projects Yale & Towne development is 100% complete and Harbor Point development is 35% complete. 2,270 residential units were approved in the last 12 months and 391 residential units are under review. The proposal to replace the former Brewer's Yacht Haven West Boatyard will demand significant staff resources in 2015-16.
- Major Planning Projects State TOD project at the Transportation Center, Veterans Park redesign (underway), Village Commercial zoning expansion in Glenbrook/Springdale, West Side rezoning.

Financial Highlights

• The Land Use Bureau typically operates within its budget with salaries and benefits comprising 96% of the total. Annual revenues from permit fees and application fees total approximately \$450,000. Requested budget increase for 2015-16 was driven by restoring an Environmental Analyst position to the Environmental Protection Board which will be needed in part to staff the new MS4 Stormwater Management Program – this request has been denied. Two new staff positions authorized for 2014-15 have remained unfilled – Transportation Planner and Land Use Inspector.
