Major Department accomplishments and highlights

- \$2,657,601.89 in delinquent tax revenue collected.

Cost and Revenue Summary

Costs

- Request for a full-time Attorney to enhance land use capabilities and, in particular, land use enforcement; to improve
 interface and coordination with Board of Education regarding legal claims and representation.
- Request for a part-time Legal Secretary (19 hours per week). The Law Department does not have a Legal Secretary.
 The Legal Secretary would handle general office duties such as filing, document preparation, copying, printing,
 preparing envelopes & letters. The lack of a Legal Secretary infringes on the time of and thereby reduces the skillbased productivity of the legal staff and limits the capacity of the Law Department.
- Request for Purchased Professional Services is, after salaries, the largest request. In the budget book, the FY 14/15 amount is incorrect— It should reflect that \$623,000 (not \$373,000) was appropriated for outside counsel and other professional services. The Purchased Professional Services is a variable cost line Item which fluctuates depending on the existence of claims which present conflicts which require the Law Department to retain outside counsel and the need for expert witnesses, professional consultants, and outside counsel with expertise in particular areas of law. Additionally, the outside counsel representing the City in union contract negotiations is paid from this line Item.

Revenue

- The Law Department revenue consists of billing to the WPCA and the Board of Education for legal services.
- While not counted as revenue to the Law Department, the Law Department generates revenue for the City by
 collecting delinquent real estate taxes, delinquent personal property taxes, and by recovering damages for
 destruction of or injury to City property. The Law Department also seeks recovery of workers compensation payments
 made in fraudulent claims and from third party tortfeasors.
- The Law Department is also in the process of establishing a 501(c)(3) in order to enable the City to accept donations
 for the Animal Control Center by insuring that donated funds will be used only for the benefit of the animals and the
 ACC.
- If the Law Department has adequate staff to enhance land use enforcement, it can be expected to generate additional revenue for the City.

 - Relatively small staff to handle the volume of work/the number of clients served (see benchmarks at p.3)
