



Seeing the young kids on the ice at the early hours of the morning before their school gives me hope for a healthy future generation of responsibility, good discipline, good physical and mental health.

The Terry corners rink has been a great asset in the summer as well. The summer camp has been very effective in getting our kid's to be involved in sports and learning.

The place has been great for parents. Socializing and sharing ideas how to best prepare our kids for a safe, healthy and positive future has been taking place through the rink as well.

If we were to battle obesity and drug use, cutting the budget to the rink is not the answer.

The physical and psychological devastation on the current users of the rink as well as the potential future users is a big price to pay if we were not to keep the place open.



I understand that the Covid-19 pandemic is forcing the City of Stamford to make tough financial decisions. However, having a City-operated ice rink is a true asset, and its value should not be underestimated, in my opinion. Indeed, having an affordable ice rink located in an attractive location like Cove Park can't be beat, and is a real draw to the area.

My family has grown up at the Terry Conners ice rink and we consider it a second home.
