Committee Budget Meeting Report

The Fiscal Committee met as indicated above to review the Fiscal Year 2023-24 budget. In attendance in person were Co-Chairs Boeger and Miller and Committee Member Reps. Fedeli, Figueroa, Goldberg, Pierre-Louis, and Tomas. In attendance remotely were Committee Member Reps. Coleman, Garst, Morson, and Shaw. Also present in person were Rep. Weinberg, Mayor Simmons, and Bridget Fox, Chief of Staff. Also present remotely were Reps. Adams, Campbell, de la Cruz, Matheny, Mays, and Sherwood; Elda Sinani, Anthony Romano, and Adrienne Tovar, OPM; and Sandra Dennies, Director of Administration.

Co-Chair Miller called the meeting to order at 5:30 p.m.

Mayor Simmons read the <u>attached letter</u> to the Committee.

The Committee first considered the Board of Education Budget. A motion to approve the Education Budget in the amount of \$313,562,896 was made, seconded, and approved by unanimous voice vote. (Reps Boeger, Miller, Coleman, Fedeli, Figueroa, Garst, Goldberg, Morson Pierre-Louis, Shaw, and Tomas in favor).

Brennan Golf Course Fund in the amount of \$1,919,488, the Terry Conner's Ice Rink Fund in the amount of \$1,330,823, the Active Medical Fund in the amount of \$40,347,104, the Risk Management Fund in the amount of \$19,556,367, and the Water Pollution Control Authority Fund in the amount of \$28,327,712 was made, seconded, and approved by unanimous voice vote. (Reps Boeger, Miller, Coleman, Fedeli, Figueroa, Garst, Goldberg, Morson, Pierre-Louis, Shaw, and Tomas in favor).

A motion to approve a resolution adopting the Capital Budget in the amount of \$88,936,000 was made, seconded, and approved by unanimous voice vote. (Reps Boeger, Miller, Coleman, Fedeli, Figueroa, Garst, Goldberg, Morson, Pierre-Louis, Shaw, and Tomas in favor).

The Committee then considered the Operating Budget. A motion to approve the Operating Budget in the amount of \$647,206,174 was made and seconded.
