## RESOLUTION NO. 4212 APPROVING AN ADDITIONAL TAX RATE TO PROVIDE FUNDS TO A RESERVE FUND FOR CAPITAL NONRECURRING EXPENDITURES TO SUPPORT THE FUNDING OF FUTURE CAPITAL PROJECTS UNDER CGS §7-361 AS RECOMMENDED BY THE BOARD OF FINANCE FOR FISCAL YEAR 2023-2024

**WHEREAS**, pursuant to Section 8-30-10 of the City of Stamford Charter on May 15, 2023, the Board of Finance determined and fixed the tax rates and service charges upon the ratable estate in each of the tax districts for real property of the City as follows

***Tax District "A": 24.55 mills***  
***Tax District "B": 24.07 mills***  
***Tax District "C": 23.78 mills***  
***Tax District "C/S": 24.18 mills***

; and

**WHEREAS**, CGS §7-361 grants municipalities the authority to levy a tax to provide funds for a reserve fund for capital and nonrecurring expenditure stating "Upon the recommendation of the budget-making authority and approval by the legislative body, there shall be paid into such reserve fund ... amounts raised by the annual levy of a tax not exceeding four mills for the benefit of such fund, and for no other purpose, such tax to be levied and collected in the same manner and at the same time as the regular annual taxes of the municipality ...;" and

**WHEREAS**, on May 15, 2023, the Board of Finance determined to create a reserve fund in the amount of \$15,000,000 to be attributed to the Capital Nonrecurring Fund for expenditures for the Long Term Facilities Plan for the public schools, to be raised by the annual levy of tax, resulting in an additional tax rates of .68 or .69 mills in each of the tax districts for real property, subject to the approval of the Board of Representatives, as follows:

***Tax District "A": .69 mills***  
***Tax District "B": .69 mills***  
***Tax District "C": .68 mills***  
***Tax District "C/S": .68 mills***

; and

**WHEREAS**, such additional tax would result in tax rates and service charges upon the ratable estate in each of the tax districts of the City as follows

***Tax District "A": 25.24 mills***  
***Tax District "B": 24.76 mills***  
***Tax District "C": 24.46 mills***  
***Tax District "C/S": 24.86 mills***

**NOW THEREFORE, IT IS HEREBY RESOLVED** by the 31<sup>st</sup> Board of Representatives of the City of Stamford that the following additional tax rate and service charges are hereby approved:

***Tax District "A": 25.24 mills***  
***Tax District "B": 24.76 mills***  
***Tax District "C": 24.46 mills***  
***Tax District "C/S": 24.86 mills***

; and


**BE IT FURTHER RESOLVED** that the proceeds of such additional tax rate and service charges shall be attributed to the Capital Nonrecurring Fund.
