## History:

- 40 yrs. + Operations / Pacific House formed by coalition of community stakeholders
- Program Goal: Engage, assist, gain housing stability

## Staffing:

- 1.5 FTE / Full Time Program Manager and Part-Time Staff
- Management Oversight: Chief Program Officer

## Program Activities:

- Outreach / Case management / Client Need Assessments / Service Planning
- Stamford Locations: Ferguson Library / Train Stations / I-95 Underpass
- Daily Operation / Variable Shifts

## Collaboration:

- Stamford and Metro North Police, DMHAS Crisis Team, Liberation Programs
- Interface with Pacific House Emergency Shelter and Supportive Housing
- Stamford Dept. of Social Services / Stamford Dept. of Public Health
- Optimus Healthcare and Stamford Hospital







## Summary of Program Performance:

- 117 unsheltered clients assisted by Street Outreach Service in FY24
- 370 unsheltered clients assisted over 5 Years (FY2020 - FY24)
- Comparison: 143 sheltered clients assisted in FY24 through Emergency Shelter Service
- FY23 Study: 39% of unsheltered clients assisted transitioned into stable housing

## Challenges:

- Lack of affordable housing and rental subsidies
- Inadequate funding support for outreach and support services
- Economic uncertainties
- Policy changes at state and federal level
