WHEREAS, at the June 23, 2014 Fiscal Committee meeting, the Fiscal Committee voted 7-0-2 to recommend acceptance of the resubmitted budget, in the amount of \$26,087,723.

BE AND IT IS HEREBY RESOLVED BY THE 29th BOARD OF REPRESENTATIVES THAT Resolution No. 3650, approved at the May 6, 2014 Special Budget Meeting, is hereby amended to read as follows:
