IN GRANT FUNDS FROM THE STATE OF CONNECTICUT
DEPARTMENT OF HOUSING FOR GENERATOR UPGRADES
AND REPLACEMENT AS PART OF
THE COMMUNITY DEVELOPMENT BLOCK GRANTDISASTER RELIEF PROGRAM- (CDBG-DR)

WHEREAS, it is desirable and in the public interest that the City of Stamford\_make application to the State for \$303,795 in order to undertake a CDBG-DR Program and to execute an Assistance Agreement therefore, should one be offered.

**NOW, THEREFORE, BE IT RESOLVED** By The 29<sup>th</sup> Board of Representatives of the City of Stamford:

- 1. That it is cognizant of the conditions and prerequisites for State Assistance imposed by Part VI of Chapter 130 of The Connecticut General Statutes; and,
- 2. That the filing of an application by the City of Stamford\_in an amount not to exceed \$303,795 is hereby approved, and that David R. Martin, Mayor of Stamford, is authorized and directed to file such Application with the Commissioner of the Department of Housing, to provide such additional information, to execute such other documents as may be required by the Commissioner, to execute an Assistance Agreement with the State of Connecticut for State financial assistance if such an Agreement is offered, to execute any Amendments, rescissions, and revisions thereto, and to act as the authorized representative of the City of Stamford.
