RESOLUTION NO. 3775 RESOLUTION TO OBTAIN CLEAN WATER FUND FINANCING FOR WATER POLLUTION ABATEMENT FACILITIES

WHEREAS, the City of Stamford has made application to the State of Connecticut for funding for a comprehensive study of the headworks and aeration system and the infiltration and inflow and sanitary sewer evaluation studies at the water pollution control facility.

WHEREAS, the State of Connecticut has approved the application and proposes to enter into a Project Grant Agreement between the State of Connecticut acting by the Commissioner of the Department of Energy & Environmental Protection (the "DEEP") and the City of Stamford (the "Municipality") under the Clean Water Fund Program.

The Mayor is further authorized to provide such additional information and execute such other documents as may be required by the state or federal government in connections with said contracts and to execute any amendments, rescissions and revisions thereto.
- 2. The City and Town Clerk is authorized to impress the seal of the City of Stamford on any such document, amendment, rescission, or revision.
