RESOLUTION NO. 4192 AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE CONNECTICUT DEPARTMENT OF ENERGY AND ENVIRONMENTAL DEVELOPMENT

BE IT FURTHER CERTIFIED THAT Caroline Simmons was elected Mayor and that her term of office began on December 1, 2020 and will continue until November 30, 2024. As the Mayor, Caroline Simmons serves as the Chief Executive Officer for the City of Stamford and on _____, 2023 had both the authority and the office to enter into agreements on behalf of the City of Stamford and to sign on behalf of the City of Stamford for financial assistance to rehabilitate and improve the playscape area at the Boys & Girls Club Yerwood Center.
