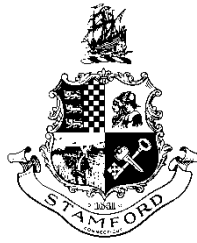

We have ad hoc data governance done on a project-by-project basis. We are looking for advisory regarding overall technology governance notably data governance and cyber governance.
