## RESOLUTION NO. 4363 AUTHORIZING THE MAYOR TO ENTER INTO AND SIGN AGREEMENTS WITH THE USDOT FHWA FOR SAFE ROUTES TO SCHOOLS SIDEWALKS 2024 PROJECT

**AND BE IT CERTIFIED** that Caroline Simmons was elected Mayor, that her term of office began on December 1, 2021 and will continue until November 30, 2025, and that, as the Mayor, Caroline Simmons serves as the Chief Executive Officer for the City of Stamford and on March 3, 2025 has both the authority and the office to enter into agreements on behalf of the City of Stamford.
