## RESOLUTION NO. 4449 AUTHORIZING THE MAYOR TO ENTER INTO AND SIGN AGREEMENTS WITH THE OFFICE OF EARLY CHILDHOOD.

**WHEREAS**, the City of Stamford has been awarded financial assistance from the Office of Early Childhood (OEC) under Early Start CT, through its LGP Quality Enhancement program, to support Early Childhood Quality Enhancement activities. The City of Stamford approved the appropriation for the support of these programs, which are funded by OEC under Early Start CT. The appropriation for this funding was approved at a regular meeting of its Board of Representatives on June 1, 2026.

**BE IT RESOLVED**, that Caroline Simmons, Mayor of the City of Stamford, may enter into an agreement with and deliver to the Office of Early Childhood (OEC), on behalf of the City of Stamford, all documents which it deems to be necessary or appropriate related to support Early Childhood Quality Enhancement programs.

**NOW, THEREFORE, BE IT RESOLVED** that Caroline Simmons, as Mayor of the City of Stamford, is authorized and directed to enter into, execute and deliver any and all agreements and ancillary documents on behalf of the City of Stamford and to do and perform all acts and things which she deems necessary or appropriate to carry out the terms of said grant and such agreements.

**AND BE IT CERTIFIED** that Caroline Simmons was elected Mayor, that her term of office began on December 1, 2025 and will continue until November 30, 2029, and that, as the Mayor, Caroline Simmons serves as the Chief Executive Officer for the City of Stamford and on, 2026, has both the authority and the office to enter into agreements on behalf of the City of Stamford and to sign on behalf of the City of Stamford for financial assistance for the support of the Early Start CT programs.
