The hearing will be held at 6:30 pm in the Democratic Caucus Room on the 4th floor of the Government Center at 888 Washington Boulevard, Stamford CT.</p> <p>The Act provides tax credits to businesses that contribute to projects operated by community organizations and approved by the Board of Representatives. Eligible projects include community services, job training or education, crime prevention, neighborhood assistance, energy conservation, and construction or rehabilitation of dwelling units for families of low and moderate income.</p> <p>Each organization submitting an application must certify that it does not discriminate against any person or group of persons on the grounds of race, color, religious creed, age, marital status, national origin, ancestry, sex, intellectual disabilities, sexual orientation, or physical disability including, but not limited to, blindness, in the provision of services related to the program(s) under consideration for inclusion in the Neighborhood Assistance Act.</p> <p>Ten (10) copies of each application must be submitted to the Grants Office, 10th Floor, at the Government Center by Tuesday, May 2, 2017.
