SUMMARY OF PROPOSED ORDINANCE SUPPLEMENTAL
AMENDMENT TO CODE OF ORDINANCES, CHAPTER 148, ARTICLE
V, SECTION 148-87, CREATION OF A COMMERCIAL LINKAGE
AFFORDABLE HOUSING PROGRAM

This proposed ordinance amends Chapter 146, Housing Standards, Article V, Commercial Linkage for Affordable Housing, Section 146-67, of the Code of Ordinances to increase the percentage of building permit fees collected by the City of Stamford Building Inspection Department for deposit into the City of Stamford Affordable Housing Trust Fund from five (5%) percent to ten (10%) percent.
