## **SERVICES OFFERED**

<sup>1</sup>Mr. Shaplen from Inspirica stated:

- Mission is to break the cycle of homelessness by helping people achieve and maintain permanent housing and stability in their lives
  - By not only addressing the physical components of homelessness but the underlining reasons: history of incarceration; mental illness; substance abuse etc.....
- Combine Residential and Support Services of Homelessness
  - In-house Housing agency
  - Vocational Training (designed specifically for extremely low-income residents)
  - In-house job placing agency (Jump Start Career Program)

- Jump Start Vocational Training Program (Culinary Arts program & Social Enterprise which is hands on training in a cafe)
- Jump Start Education is a 13 week education program designed for extremely low-income residents
  - Building Foundation
  - Getting to work and Staying at work
- Jump Start employment Agency
  - 191 job placements
  - Average wage was \$11.18 (29% above minimal wage)
  - 85% placed earned over \$9.00
  - 57% placed earned over \$10.00
  - 25% placed earned over \$12.00
  - Working on average 30 plus hours a week
  - After 1 month of employment 87% are still employed
  - After 3 months of employment 83% are still employed
  - After 6 months of employment 81% are still employed
  - Last four years 680 job placements
    - Moved 587 men/women/children into permanent housing
    - Retention rate on permanent housing
      - 1 month 100%
      - 3 months 98%
      - 6 months 94%
- o In-house job and housing retention program
- o In-house healthcare
- o In-house children services program
- Programs are integrated

  - Transitional housing

<sup>2</sup>Mr. Jerome Roberts from Shelter from the Homeless passed out several documents regarding the Shelter for the Homeless (SFH-Dashboard; SFH-Profile; SFH-Pamphlet):

- Shelter for the Homeless began in 1985 (Pacific House)
- Serves 550 single Men
- Offers meals (continental breakfast/hot dinner)
- 55,000 meals yearly
- Day drop in program (8am 5:30pm)
- Services Referral Case Management
  - Vocational-Career Development
  - o Bilingual Hispanic
  - Mental Heath
  - General Case Management Services
- Shelter Base Recovery Program
  - 12 men who have fell out of the traditional treatment
  - o On staff Drug and Alcohol Counselor
  - If a member fails and uses they are not automatically terminated; services are extended
  - o 33% success rate for 1 year or more clean

<sup>3</sup>Mr. Roberts states it has seen an increase in general homelessness and chronic homelessness. Chronic homelessness is long-term or repeated homelessness often coupled with a disability. Mr. Roberts states during 2013 the Pacific house shelter exceeded its base capacity of 67 individuals almost nine days out of every 10. (Please see attached "<u>Capacity</u>") Mr. Roberts states they are over extended in all of their services. There is a lack of affordable housing in Stamford. The area's median income is \$100,000 plus. The residents that we help are at 25% or below the area's median income.

<sup>4</sup>Mr. Shaplen states there is a crisis in Stamford. You may not see it on the Streets yet because of what the Shelter for the Homeless and Inspirica are doing. In the last 2 years there has been a 43% increase in homelessness in Stamford compared to a 6% increase state wide. Since 2009 Stamford has seen a 72% increase in Chronic Homelessness compared to a 40% increase state-wide. All of their programs are at 100% capacity year round and in the winter 110% plus capacity. Mr. Shaplen said Stamford needs is more shelters and more affordable housing. Inspirica decided to look at a new market called "deeply affordable housing" which would help families making 25% or below the area median income.

<sup>5</sup>Mr. Roberts talked about the projects they are working on that are geared towards individuals. (please see attached <u>Light House 1</u>-Single Room occupancies)

Chair Mitchell and the committee agreed that homelessness is a continued
