In response to the Coronavirus/COVID-19 pandemic, on March 27, 2020 the President signed the Coronavirus Aid, Relief and Economic Security (CARES) Act, Public Law 116-136, to assist communities in addressing the growing needs made apparent by this public health crisis. In connection with the CARES Act, the <u>City of Stamford was allocated an additional \$574,820</u> in funding (CDBG-CV funds) to address the COVID-19 pandemic and its impact on the community.
