



Re: Charter Section C6-40-5 **Petition Opposing** Map/Zone Change from R-20 to RA-1 for Six Properties on Saddle Rock Road - File # 213-33 ("Application")

Dear Members of the Zoning Board:

On January 27, 2014, the Zoning Board of the City of Stamford granted Mr. Redniss' Application, as modified, to change the zoning classification of six (not seven) properties located 74, 88, 89, 102,107 and 123 on Saddle Rock Road in the City of Stamford, County of Fairfield and the State of Connecticut.

A legal notice announcing the approval, as modified, of the above referenced Application was published in the January 31, 2014 edition of the Stamford "Advocate."

The owners of property within 500 feet of the area included in the Approved As Modified Application of Richard Redniss (File # 213-33) to amend the Zoning Map of the City of Stamford, Connecticut **object to** the Map/Zone Change from R-20 (20,000 square feet minimum lot size) to RA-1(one acre minimum lot size) for the six properties located at 74, 88, 89, 102,107 and 123 on Saddle Rock Road in the City of Stamford, County of Fairfield and the State of Connecticut.

Pursuant to Section C6-40-5 of the Charter for the City of Stamford attached are signed Petitions of the owners of more than 20% of the privately-owned property located within 500 feet of the area included in the Approved as Modified Application of Richard Redniss objecting/protesting the aforementioned change in zone classification for the six properties. In support of the Petitions I have also attached the following documents:

- 1. Two 500 feet abutters' lists prepared by the City of Stamford's Tax Assessor's Office. One of the abutters' lists is based on the borders for 74 Saddle Rock Road and the second abutters' list is based on the borders for 89 Saddle Rock Road. (See Exhibit B)
- 2. Exhibit C, attached, combines the two abutters' lists and shows that the owners of 39.75% (or almost twice the threshold required percentage of 20%) of privately-owned property within 500 feet of the area re-zoned object/protest such zone classification change.



MAP TITLE




