

The Regional Performance Incentive Program, administered by the Office of Policy & Management (OPM), is designed to encourage the joint provision of services currently provided by individual municipalities but not presently provided on a multi-town basis. The program is entirely funded by OPM with no financial requirements of the participants.

The purpose of the Regional Watershed Service would be to assist municipalities in meeting the requirements of local Municipal Separate Storm Sewer Systems (MS4s) permits. The major objective of the service would be to design and execute an education and outreach campaign around water resource preservation and address the requirements for each municipality's MS4 permit. The service would consist of a full time contract employee or consultant, a Regional Watershed Coordinator, whose charge would be developing and executing an outreach program designed to meet MS4 requirements well assisting municipal staff. The coordinator would also identify projects and practices that could be applied across southwestern Connecticut to enhance and protect water quality while furthering the communities understanding of their connection to these precious resources. In addition, the regional watershed coordinator position would identify additional components of the individual MS4 permits that could be addressed on a regional basis, freeing up the time and money from local staff who are currently dedicated to meeting their town's MS4 requirements.

If funded, the Regional Watershed Service would sustain the momentum built during the watershed planning process over the past three years by furthering the relationships and knowledge sharing established. It would also create a new municipal forum for cooperation on issues related to water resource preservation and watershed management.

In 2012, Darien, Greenwich, New Canaan, Norwalk and Westport passed resolution indicating an interest in participating in the proposed watershed service. The 2013 project proposal has been revised to reflect participation of these five municipalities and redefining the regional watershed coordinator as a contract position based on advisement from OPM.
