RESOLUTION NO. 3748 APPROVING THE DEMOLITION OF THE BUILDING LOCATED ON THE PROPERTY AT 671 BEDFORD STREET, STAMFORD, CT PURSUANT TO SECTION 9-10 OF THE CODE OF ORDINANCES

WHEREAS, on May 6, 2015, the Board of Representatives approved the City's purchase of the real property known as 671 Bedford Street, Stamford, CT together with any improvements thereon, which purchase had been previously approved by the Planning Board and the Board of Finance; and

WHEREAS, Section 9-10.B of the Code of Ordinances of the City of Stamford states the Mayor shall request approval of demolition of an unused city-owned building or structure from the Planning Board, the Board of Finance and the Board of Representatives; and

WHEREAS, upon approval of the three boards, the Mayor shall direct the Director of Operations to apply for a demolition permit pursuant to Chapter 88 of the Code of the City of Stamford; and

WHEREAS, there is one building located on the property at 671 Bedford Street; and


WHEREAS, the building on the site of the property at 671 Bedford Street adds no value to the property in conjunction with the proposed plan to develop the property as a new Police Station Headquarters; and

WHEREAS, it has been determined that it is in the best interest of the City of Stamford to permit the demolition of the building on the site of the property at 671 Bedford Street.

NOW THEREFORE BE IT RESOLVED that the 29th Board of Representatives, pursuant to Section 9-10.B of the Code of Ordinances of the City of Stamford, does hereby approve the demolition of the building on the site of the property at 671 Bedford Street.

This resolution is effective upon enactment.
