Ralph/David/Vineeta – snapshots of current versions of drawings below – these are interim and our plan was to finish these and present to staff this week.

These have changed substantially in response to Staff comments:

- Changed roofline of north tower to “stepped” and removed the observatory to differentiate from south tower
- Changed colors of north tower to differentiate from south tower
- Broke up balcony pattern to create distinction in the towers themselves
- Changed colors/patterns on Pacific to create variation among the sections as well as a vertical gradation pattern (already showed earlier version of this to Staff)





What we are working on now is:

- Detail of landscaping and at-grade entries along Pacific Street – I may be able to get this today
- Detail of finishes on all facades
- Detail of Commons Park North/sidewalks, landscaping (working on this with Jim Travers)
- Minor modifications to site plan to accommodate Staff comments

We would then produce great looking renderings of Pacific which will show the articulations and detail at grade, as well as any other views you think we need to tell the story.
