I wanted to reach out to make your aware of a transportation issue which will be voted on this upcoming Monday, December 2nd by the Board of Representatives that will impact both your employees commutes to/from work and shuttle operations to/from the Transportation Center.

As you may recall, when we met with you earlier (in April) of this year we showcased a 5M+ investment to improve transportation in the Waterside Corridor.

The Waterside Circulator project includes the intersections of Greenwich Avenue at Selleck Street (substantially complete), significant improvements to Davenport Street (utility work scheduled to beginning early next year), milling and repaving of Greenwich Avenue and of course the Greenwich Avenue/Pulaski Street Roundabout. The project will ultimately create a one-way circulator to improve access between the highway, transportation center and your offices.

Since our last meeting, our Department has negotiated with Charter (as part of their Zoning Approval), to contribute 1.9M to widen both Washington Boulevard (between Henry Street and Pulaski Street) and Pulaski Street, east of the bridge. This past Monday night our land use committee deliberated the issue of eminent domain, the result was 4-4 tie (failure) to initiate the process of acquisition of property by negotiation or eminent domain for the rights of way necessary to make this project a reality. Dear Garrett, after receiving your email regarding the above-mentioned project, reading the content of your email and discovering that this vital main roadway improvement project in our rapidly growing town may be shutdown shocked me. This project has been under consideration for quite some time now and all signs pointed to a positive outcome that will improve safety, reduce dangerous congestion and also improve the "look" of a heavily traveled area by vehicle, pedestrians and cyclists. To hear the last vote ended in a tie which equals a fail is disheartening. Please share the content of this letter on our behalf.
