#### SUMMARY OF PROPOSED ORDINANCE PROVIDING FOR THE CREATION OF AN HISTORIC PRESERVATION TRUST FUND IN THE CITY OF STAMFORD

This ordinance creates Chapter 29, Article I of the City of Stamford Code of Ordinances, establishing the Stamford Historic Preservation Trust Fund (the "Trust") to provide for the preservation and rehabilitation of historic buildings, landscapes and places within the City, including programs designed to create awareness about historic structures and places and historic preservation as well as the provision of technical or monetary resources for such preservation. The ordinance provides, in part, that: 1) The Board of the Trust shall consist of the Land Use Bureau Chief, the Chair and Vice-Chair of the Historic Preservation Advisory Committee, the Chair of the Land Use / Urban Redevelopment Committee of the Board of Representatives, and the Chair of the Board of Finance or their designees; 2) The terms of the Trust will be set forth in a Declaration of Trust approved by the Board of Representatives and the Mayor. The Trust shall be funded by a) sums appropriated by the City; b) monies received by the City for the preservation and rehabilitation of historic buildings or places; and c) a fee of \$500 from applicants seeking addition to the City's Cultural Resource Inventory; 3) Expenditures from the Trust may only be made for: a) grants or loans for the preservation, rehabilitation or adaptive reuse of historic buildings and sites; b) studies to inventory and assess historic buildings or places; c) city or district historic preservation plans of projects that enhance the public understanding of historic buildings or places; e) the acquisition of historic buildings or places; and f) staff support for maintaining the City's Cultural Resources Inventory, research activities and the support of HPAC.

#### SUMMARY OF PROPOSED ORDINANCE AMENDING CHAPTER 21, FACILITIES, CITY-OWNED, ARTICLE II - GUIDELINES FOR NAMING AND RENAMING OF STREETS, PARKS AND FACILITIES SECTION 21-3 - NAMING OF CITY OWNED FACILITIES

This ordinance amends Chapter 21, Article II, Section 21-3 of the City of Stamford Code of Ordinances regarding the naming of city owned facilities to bring the requirements for renaming existing city streets in line with commemorative naming of city streets. Changes include: 1) Increasing the required vote for waiving the requirement that a person being memorialized be deceased for six months and have substantially contributed to such street or facility or the entire community, from 2/3 to 3/4 of the entire Board; 2) requiring a petition in favor of the proposed renaming of a street to be signed by 3/4 of the record owners of such street or segment thereof; 3) requiring the Board to hold a public hearing on the renaming of any city street; and 4) requiring approval of 3/4 of the Board present and voting of the renaming of any city street.
