

SECOND AMENDMENT TO AGREEMENT

THIS SECOND AMENDMENT AGREEMENT dated the day of , 2021, by and between the **CITY OF STAMFORD**, a municipal corporation in the State of Connecticut, hereinafter referred to as the “City”, acting herein by David R. Martin, its Mayor, hereunto duly authorized, and **BUCKHURST FISH & JACQUEMART, INC.**, 1115 Fifth Avenue, New York, New York 10003, hereinafter referred to as the “Consultant”, acting herein by Georges Jacquemart, Principal, PE, AICP, PP, duly authorized.

W I T N E S S E T H

WHEREAS, the City issued Request for Proposals No. 776 for a Citywide Parking Plan; and,

WHEREAS, the Consultant submitted a Proposal in response to said Request for Proposals, and was selected by the City to provide the requested services; and

WHEREAS, the parties thereafter entered into an Agreement pursuant to which the Consultant was to perform the contract services within a period of one year; and

WHEREAS, the Consultant has been unable to complete performance of its contract duties due to the restrictions placed upon it by the COVID-19 pandemic; and

WHEREAS, the Agreement contemplated additional services to be performed by the Consultant, the extent of which and the cost of which could not reasonably have been anticipated by the parties as of the date upon which the Agreement was executed; and

WHEREAS, the parties have now determined the extent of such additional services and reasonable compensation therefor;

NOW THEREFORE, THE PARTIES AGREE THAT THE AGREEMENT SHALL BE AMENDED AS FOLLOWS:

1. AMENDED SCOPE OF SERVICES. The Agreement between the parties shall be amended to provide that the Consultant shall perform all those services set forth in correspondence from the Consultant to the City dated February 18, 2021, attached hereto as Exhibit A and made a part hereof.

2. COMPENSATION. Compensation for such additional services shall not exceed Forty Five Thousand Dollars (\$45,000.00) and shall be based upon the following estimates:

PHASE ONE: General Feasibility Framework of Real-Time Information
Platform \$13,500.00

PHASE TWO: Detailed Feasibility and Implementation Plan
\$18,500.00

3. REMAINING TERMS AND CONDITIONS. . All of the remaining terms and conditions of the Agreement shall remain in full force and effect until such time as all duties encompassed by RFP No. 776 have been completed by the Consultant.
