## **RESOLUTION NO. 4128**

AMENDING RESOLUTION NO. 4085, AS AMENDED BY RESOLUTION NO. 4101, CONCERNING THE APPOINTMENT OF A SOUTH END HISTORIC DISTRICT STUDY COMMITTEE TO EXTEND THE DATE BY WHICH THE STUDY COMMITTEE SHALL SUBMIT ITS REPORT

WHEREAS, on February 1, 2021, pursuant to Section 7-147b of the Connecticut General Statutes, the Board of Representatives, by Resolution No. 4085 appointed a South End Historic District Study Committee (the "Study Committee"); and

WHEREAS, under Resolution No. 4085, the Study Committee is required to submit its report prepared pursuant to Section 7-147b of the Connecticut General Statutes to the State Historic Preservation Office, the Planning Board and the Board of Representatives within six (6) months of the date of approval of the Resolution, which date is August 1, 2021; and

WHEREAS, Resolution No. 4085 further provides that the Board of Representatives may extend said six (6) month period upon request by the Study Committee and cause shown; and

WHEREAS, upon the request of the Study Committee, the Board of Representatives granted an extension of said six (6) month period to May 1, 2022, under Resolution No. 4101; and

WHEREAS, the Study Committee has requested an extension of an additional six (6) month period.

NOW THEREFORE BE IT RESOLVED BY THE 31<sup>ST</sup> BOARD OF REPRESENTATIVES THAT: the Study Committee shall submit its report to the State Historic Preservation Office, the Planning Board and the Board of Representatives on or before November 1, 2022. The Board of Representatives may extend this period upon request by the Study Committee and cause shown.
