Place: This meeting was held remotely.

The Land Use-Urban Redevelopment Committee met as indicated above. In attendance were Co-Chair Sherwood, Co-Chair Tomas and Committee Member Reps. Adams, Campbell, Camporeale, de la Cruz, Kuczynski, Matheny, and Summerville. Also in attendance were Reps. Boeger, Cottrell, Patterson, Strain, and Walston; Burt Rosenberg, Assistant Corporation Counsel; Jody Bishop-Pullan, Director of Health & Human Services, and Ebrima Jobe, Director of Environmental Health & Inspection. Absent or excused were Reps. Grunberger, and Mays.

Co-Chair Tomas called the meeting to order at 7:00 p.m.

Assistant Corporation Counsel Rosenberg reiterated prior testimony on the following:

- The Board of Representatives' authority to approve contracts over \$100,000 applies only to purchases under the purchasing ordinance.
- Cited Charter Section C3-10-12, affirming the mayor's authority to enter into contracts.
- The MOU in question does not involve a purchase; therefore, the purchasing agent was not involved, and board approval is not required.
- No city funds or escrow account funds are being used for the Garden Street project.
- The TIF agreements establish escrow funds, but none are allocated to this specific project.
- Allegations of zoning violations related to the easement in the MOU are not within the Board of

- Representatives' purview, such matters fall under the jurisdiction of the Zoning and Planning Boards.
- The third amendment to the agreement has not been located by the Law Department or Ben Barnes' office.
- Assistant Corporation Counsel 7Rosenberg repeatedly requested Attorney Waters (representing BLT) attend meetings to clarify issues, including fund usage and the missing amendment.
 Despite multiple invitations, Attorney Waters has not responded or attended.

Director Jobe summarized the complaint and inspection process:

- Complaints must be formally filed through the department's reporting platform before inspections can be initiated
- For bed bug investigations, an inspector must collect a specimen then the specimen must be lab-confirmed as a bed bug before any action is taken.
- Without a name, contact info, and unit number, inspections cannot proceed due to procedural limitations.
- In July 2025, eighteen units were inspected for bed bugs; only one tested positive.
- The department issued a violation order for that unit, but the tenant refused entry, limiting enforcement.
- A neighboring tenant also denied access for sample collection, preventing confirmation and response.
- Tenants often fear retaliation and avoid filing complaints or sharing identifying information.
- This lack of cooperation significantly hinders the department's ability to investigate and act.
- The department aims to respond within 48–72 hours, but delays may occur due to limited staffing (11 inspectors covering 16 city programs).
- Director Bishop-Pullan offered her services to collaborate on potential solutions—either with members of the committee or the administration.
