**SUMMARY OF PROPOSED ORDINANCE  
AMENDING CHAPTER 220, TAXATION,  
ARTICLE IV, SENIOR CITIZEN TAX ABATEMENT  
TO ADD FISCAL YEAR 2015/2016 PILOT PROGRAM**

This ordinance amends Article IV of the Code of Ordinances, Senior Citizen Tax Abatement, to add a pilot program for Fiscal Year 2015/16 to eliminate the tax deferral program and make several changes to the tax abatement program, including 1) increasing the net worth limitations and 2) simplifying the abatement schedule and increasing the abatement amounts as follows:

The ordinance is to take effect upon enactment and expire on December 30, 2015.
