**RESOLUTION APPROVING AN AGREEMENT BETWEEN THE
HOUSING AUTHORITY OF THE CITY OF STAMFORD AND THE CITY OF STAMFORD
FOR THE CITY'S ACQUISITION OF PROPERTY LOCATED AT
108, 172 AND 186 GREENWICH AVENUE, STAMFORD, CONNECTICUT**

NOW THEREFORE BE IT RESOLVED BY THE 29TH BOARD OF REPRESENTATIVES THAT:

Pursuant to Section C1-50-3 of the Stamford Charter and Section 9-7.1 of the Stamford Code of Ordinances, the Real Estate Sales Agreement ("Agreement") between the City of Stamford ("Buyer") and The Housing Authority of the City of Stamford ("Seller") for the City's purchase of the real property known as 108, 172 and 186 Greenwich Avenue, Stamford, Connecticut and more particularly described on Exhibit A attached hereto, for \$1.00, in accordance with the terms and conditions set forth in the Agreement, which is incorporated by reference, is hereby approved; and

The Mayor is hereby authorized to execute such Agreement and to execute any instrument he deems necessary or desirable in connection with the execution of such Agreement.

This Resolution shall be effective as of the date of approval.

**RESOLUTION APPROVING A LEASE
BETWEEN THE BOARD OF EDUCATION OF THE CITY OF STAMFORD
AND OLD TOWN HALL QALCIB, LLC FOR A PORTION OF THE BUILDING LOCATED AT
175 ATLANTIC STREET, STAMFORD, CT**

NOW THEREFORE BE IT RESOLVED BY THE 29TH BOARD OF REPRESENTATIVES THAT:

Pursuant to Section C1-50-3 of the Stamford Charter and Section 9-7.2 of the Stamford Code of Ordinances, the lease agreement ("Lease") between the Old Town Hall QALCIB, LLC (hereinafter referred to as "Lessor") and Board of Education of the City of Stamford (hereinafter referred to as "Lessee") for a portion of the building located at 175 Atlantic Street, Stamford, CT, together with a right in common with others to use the Common Areas, for any purpose related to the operations of the Stamford Public School System, in accordance with the terms and conditions set forth in the Lease, which is incorporated herein by reference, for the period commencing on July 1, 2017 and terminating on June 30, 2027, with two additional 5 years options, is hereby approved; and

The Superintendent of Schools is hereby authorized to execute such Lease and to execute any instrument he deems necessary or desirable in connection with the execution of such Lease.

This Resolution shall be effective as of the date of approval.
