## RESOLUTION NO. 3836 APPROVING THE ASSIGNMENT OF THE TAX ABATEMENT AGREEMENT BETWEEN THE CITY OF STAMFORD AND FOREST CITY EQUITY SERVICES, LLC TO RAHF IV SHIPPAN, LLC

WHEREAS, in order to continue its obligation to assure that there is safe, adequate and affordable housing to the residents of the City of Stamford, the City of Stamford entered into a Tax Abatement Agreement with Forest City Sound View Associates on or about April 23, 1979 (the "Tax Abatement Agreement"), which subsequently became Forest City Equity Services, LLC ("Forest City"); and

WHEREAS, the subject of said Tax Abatement Agreement was property located at 521 Shippan Avenue, Stamford, Connecticut, a residential property known as "Shippan Place" (the "Property"); and

WHEREAS, the sale of the Property by Forest City to RAHF IV Shippan, LLG ("RAHF") is pending and RAHF shall continue to operate the Property as housing for low and moderate income families; and

WHEREAS, it has been determined that it is in the best interests of the City, Forest City and FAHF for Forest City to assign the Lax Abatement Agreement to the RAHF and for the City to permit such assignment; and

WHEREAS, just as its predecessor, RAFIE shall continue to provide greatly needed low and moderate income housing in the City of Stamford; and

## NOW THEREFORE BE IT RESOLVED, BY THE 29TH BOARD OF REPRESENTATIVES OF THE CITY OF STAMFORD THAT:

- 1. The assignment of the Tax Abatement Agreement between the City of Stamford and Forest City to RAHF is hereby approved.
- 2. The Mayor is hereby authorized to execute any instrument he deems necessary or desirable in connection with the assignment of the Tax Abatement Agreement.
