### SUMMARY OF PROPOSED ORDINANCE SUPPLEMENTAL AMENDING CHAPTER 248, ARTICLE I OF THE CODE OF ORDINANCES; PENALTIES FOR VIOLATIONS OF ZONING REGULATIONS

This ordinance amends Article 248-1 of the Code of Ordinances to 1) decrease the fine for violations of each zoning violation; 2) permit the Mayor to appoint city employees to Issue citations in accordance with the terms of the ordinance; 3) provide for a resolution conference with the Zoning Enforcement Officer upon the request of a person receiving a notice of violation of Article 248-1; and 4) provide a penalty for knowingly filling a false report of a zoning violation.
