SUMMARY OF PROPOSED ORDINANCE NO. _____ SUPPLEMENTAL
ESTABLISHING A STAMFORD APPOINTMENTS COMMISSION

This Ordinance adds Chapter 8, Authority, Boards and Commissions, Article XVII, Stamford Appointments Commission to the Code of Ordinances creating a Stamford Appointments Commission. The ordinance provides that the Commission shall consist of 7 voting members appointed by the Mayor and approved by the Board of Representatives and 3 ex officio members. The purpose of the Commission is to facilitate the appointment process to City boards and commissions by supporting the sourcing, recruiting, and screening of appointment candidates and to serve as an information center and focal point in the City for opportunities and vacancies on City boards and commissions. Responsibilities of the Commission shall include, but are not limited to: recruitment efforts to advance awareness of City board and commission volunteer opportunities among diverse residents of City of Stamford; and serving as a screening committee for prospective qualified candidates.

CONCERNING A TAX ABATEMENT AGREEMENT BETWEEN THE

CORPORATION FOR 360 (NOW 240) BELOW-MARKET UNITS
LOCATED AT

873 WASHINGTON BOULEVARD, 109 TRESSER BOULEVARD AND
133 TRESSER BOULEVARD, STAMFORD, CT

This ordinance grants an abatement of seventy five percent (75%) of all real property taxes assessed by the City against the 360 (now 240) units located at 873 Washington Boulevard, 109 Tresser Boulevard, and 133 Tresser Boulevard, Stamford, CT, in accordance with the terms of the proposed tax abatement agreement and authorizes the Mayor to act on behalf of the City of Stamford, to execute and deliver all documents he deems necessary or desirable.

This ordinance shall take effect upon enactment.
