**SUMMARY OF PROPOSED ORDINANCE
 AMENDING CODE OF ORDINANCES CHAPTER 155 - LIGHTING,
 §155-9, ENFORCEMENT**

This Ordinance amends Chapter 155, Lighting, Section 155-9, Enforcement to specify that the ordinance may be enforced by the Zoning Enforcement Officer and/or the Chief Building Official or their designees and civil citation officers through the civil citation process and to clarify that a fine of \$100 shall be imposed per violation of the article and an additional \$100 shall be imposed for each day that such violation continues.
