**SUMMARY OF PROPOSED ORDINANCE
AMENDING CHAPTER 220, TAXATION,
ARTICLE IV, SENIOR CITIZEN TAX ABATEMENT**

This ordinance amends the current program of tax relief to senior citizens who meet certain criteria to increase the income limits for eligibility for a tax abatement and to increase the amount of such abatement as set forth below; increases the limit of total benefits under the program from \$2 million to \$2.2 million; and permits filing of an application by mail.
