Hi Megan,

The Freedom of Information Act does not prohibit voting on the consent agenda in one action and does not require board members to file motions on each item separately. However, the public must have adequate notice of what is being voted on. That is, the Board's agenda cannot just say "consent items." The agenda needs to identify each item with enough specificity so that a person reading the agenda would know what was being voted on. (This is true for all items on an agenda - consent or otherwise.)

I am told the Board of Education regularly follows the contemplated procedure, although I have not personally observed it. If there's anything else you need, please let me know.
