In fact, I remember people coming in literally from all over the country, because we had such a strong, well established group.

All of this being said, I would humbly ask whomever the appropriate official may be to please consider the tremendous influence the Community Center has had on so many people. Simply put, it saved my life. It could save many more given the opportunity.

To the board,

I'm writing this to express my disappointment in the way that the Glenbrook Community Center issue has been handled, and to plead for this issue to be handled better going forward. My understanding is that this building was used as a meeting space for GNA and AA until 2020, when it was closed due to COVID. It is also my understanding that the building hasn't been adequately maintained, and needs major repairs to be usable as a community center. In 2021, the BoR voted to put out an RFP to developers, with the intent that the building would be turned into Affordable Housing. A developer came up with a plan for 51 units, all Affordable at 40-80% of AMI. I wrote into the hearing a few weeks ago to say that I supported the affordable housing plan. And I still support it.

However, after listening to most of the hearing, I can see that there is some desire for a community center. And, frankly, I can understand the AA members who were skeptical of using a private apartment building as a meeting place. If I was in AA, I'm not sure if I would want my meetings to be in an apartment building. And I can also understand why some are skeptical of having the use of the community space be regulated by a private landlord.

Personally, I think that 51 units of Affordable housing is more valuable to Stamford as a whole than a community center. But, I'm also not a rep, and I don't receive feedback from a broad swath of residents.

It's pretty obvious that if the board wants to restore the building to a functioning, well maintained community center, privatization won't work here. A dozen non-profits were consulted about this, and none were interested in the property. The two proposals that were brought up during the hearings are not viable. I say this based on the conclusion of the Simon's administration, and an email from the GNA that was forwarded to me, which affirmed the conclusion of the Administration. We pay taxes to the city, state and federal governments for schools, roads, fire, transit and other services. Why can't the city pay for a community center using tax dollars?

My plead to you is this: either commit to restoring the GCC using public funds, or let the affordable housing project proceed. I do not see any reason to delay this.

Dear Board of Representatives (all members b'ccd),

I am writing to urge the board to revive the Crescent Street affordable housing project. The city is in desperate need of affordable housing and this project has many specific advantages that recommend it. The top line number of 51 below market rate units (100% affordable) is difficult to find in affordable housing projects and housing projects in general. The location is in a walkable neighborhood near mass transit reducing the need for car trips. The project preserves a historic building and contains space for community meetings and use. Furthermore, there is no tax abatement attached to the project. It is difficult to imagine a less objectionable affordable housing project.

I have been concerned by this board's past treatment of public hearings as referendums. If the board wishes to hold city wide referendums on decisions it should do so, but the board should not mistake sparsely attended hearings as a replacement. The legislative and rules committee was apparently swayed to trash the Crescent Street Project due to a public hearing where only 30 people provided comment. Over 130,000 people live in the city, we cannot defer major decisions to the whims of whatever tiny group happens to attend a public hearing.

I must express disappointment at the efforts by Representative Nina Sherwood to mislead the public. Mere hours before the vote and well outside the bounds of any official process additional bids were solicited to create confusion and controversy. There can be good faith disagreement over whether a community center or affordable housing are more beneficial to the city, but that disagreement was already litigated when the original RFP process began. When the RFP was created there was zero credible interest in operating the building as a community center and that still appears to be the case. The board is at risk of trashing a shovel ready project in pursuit of a mirage.

The board often talks about the need for affordable housing. Rarely has the board translated this sentiment into action. Here is a golden opportunity for the board to simply vote 51 units of desperately needed affordable housing into existence. I hope you will take it.

Dear Board Members,

My name is Jamie D'Agostino, and I am a 3rd generation, lifelong Stamford resident who grew up with the GCC. I currently have two children in the Stamford Public Schools (Davenport and Scofield) and my wife is a teacher so my local roots and commitment to the community are strong.

A little bit more about me--I am a Stamford business owner and entrepreneur. In 2003 I founded Netology, a managed service provider delivering innovative IT solutions to companies in the tri-state area. Netology was included on the "Inc. 5000" list of fastest-growing companies in America in 2017 (number 3680) and I was proud to be awarded CT Entrepreneur of the Year in the Main Street category in 2022.

As you know I am interested in purchasing the Glenbrook Community Center. Unfortunately, since RFP 828 was put out by the city in 2021 with the title "Redevelop 35 Crescent Street for Affordable Housing" I (and probably several other prospective buyers not initially interested in building housing) was unaware that I could be a potential developer. The title of the RFP alone suggests that the future use of the property was already decided by the city.

I discovered that the city was looking to sell the building in October of 2021. I was actively looking to purchase new office space for my company and also looking for a future home of a new Learning Center/Day Care venture that my wife will be launching soon. The property at 35 Crescent Street met our criteria perfectly. Now we just needed an opportunity to put forth a formal, verified, and complete bid to purchase the property from the city.

My team spoke with Mayor Martin on my behalf in November of 2021. I was then told to reach out to the new mayor in the new year. We did contact them and were told that the city was not interested in receiving more bids but would meet with us as a courtesy. I met with the mayor's team on August 22nd. They were polite yet dismissive because I did not include affordable housing in my vision. The details of my plan were never discussed in full. I want to make it clear that *interested buyers such as myself have not been given a chance to put forth formal proposals.*

My vision for the building is realistic, community-serving and feasible. It incorporated three entities/purposes:

1. Professional Day Care

My proposal would include plans for a professionally-run and funded bilingual day care that would serve up to 60 children from the community.

2. Community Services

I have a community service vision for the WHOLE building, not merely implanting a small community space inside the building husk. I believe that 1000, 2000 or even 3000 square feet of community space will not give the community what it needs.

I propose to keep the gymnasium (full indoor basketball court) and two other approx. 1000 sq. ft. rooms so they are available for community use. I also envision kitchen services for such community groups, as has been done in the past. By promoting and offering the bilingual learning services to local children, the daycare would be in itself a meaningful and engaging service to the community.

3. Netology

Netology is currently outgrowing its 2500 sq. ft. office at 1200 Summer St, a property that I am a partial owner of. We would propose to move into the top floor of the 35 Crescent Street building which is roughly 3500 sq. ft. allowing my business much-needed room for expansion.

In addition to the office space, I want to make use of the Glenbrook train station for my employees, some of whom would be reverse commuting. Netology employs 23 people, some of whom live locally in Stamford and some as far as the Bronx, Milford and Bridgeport. Currently our Summer Street office space is over a mile from the Stamford train station making it inconvenient to get to the office.

Just as the 95/rail corridor is desirable for large businesses, I believe that Glenbrook can provide easyaccess, smaller office spaces to its home-grown business-owners—especially those who have a track record of hiring and mentoring local Stamford students and young adults. My proposal would guarantee 30+ jobs remaining in Stamford make great use of the Glenbrook Train Station.

Proposed Floor plan:

4th floor: Netology Offices

3rd **floor**: Refurbished common area for both building tenants and the community with a kitchen and meeting rooms. The other two rooms on this floor would also be available to the community. **2**nd **and 1**st **floor**: These floors comprise more than 50% of the building and would be solely dedicated to the Bilingual Day Care Center.

Basement: Full indoor basketball to be open to the community

Affordable Housing

I acknowledge, and, as an employer, understand the need for local affordable housing. If given the opportunity, my proposal could include 20 to 30 affordable housing units in the back of the property. I want to be on the record that I am open to adding affordable housing to our vision should I be allowed to submit a formal bid.

State of the Building

For the record, I am aware of the building's condition, and I am neither uninformed nor deterred. I have done walkthroughs and I have spoken to people who were part of the non-profit walkthroughs in 2018/2019. I have an Engineering degree, am a successful entrepreneur and real estate investor and I have calculated what it would take to make the WHOLE building serve the community once again. I am also dedicated to preserving the historic nature of the building.

In Conclusion

Now that you have heard more about me as a potential buyer and read about my vision, I am hoping that you will consider voting down the current 51-unit proposal because keeping a viable community center at 35 Crescent is more than possible—it is achievable.

I am financially able to see my concept come to fruition. I look forward to showing these means if and when I can submit a formal proposal. It is my hope that the mayor and the Board of Representatives strongly consider alternative uses and solutions to save this beautiful building and preserve its history by allowing it to continue serving the community.

Not only is the offering price ridiculous, but the question also has to be asked, what benefit does the proposal provide for the Glenbrook community, and are there perhaps better uses to enhance the quality of the Glenbrook Community? Does the proposal address the needs of a well-balanced community? I think not.

There has been a lot of residential growth in the Springdale and Glenbrook neighborhoods that has resulted in an increase in development, traffic, and congestion.

I remember not too long ago visiting the center run by a previous Director. I have attended events there and have even campaigned there. I would like to speak to the acute need for more housing in Stamford, especially affordable workforce housing. I encourage the Board to do more to increase our housing stock. The Mayor's office said that it receives dozens of calls each week from residents who face eviction or cannot afford their current housing. Don't jump to conclusions. Business leaders have told the Mayor they can't fill job openings because prospective employees can't find housing including everyday people with good paying office jobs. It is fundamentally a supply problem.

In a CT Insider article, Jay Lybik, National Director of Multifamily Analytics at CoStar Group, a real estate analytics company, was quoted "There's always been very little new supply in Connecticut. Because there is so little new construction, rental housing was always super tight. You'd see rental increases year over year that were pretty consistent." This is happening because people who are opposed to new construction fight every conceivable housing proposal of any kind anywhere in Stamford. Small to mid-size developers who specialize in smaller projects can't afford to take on these housing opponents who target their proposals through petitions, blocking tactics of certain Representatives, and lawsuits. Given these facts, Representatives should not feign surprise that luxury homes dominate what little new home construction there is. The pressure on rents is relentless. According to CoStar and the US Census Bureau rents have risen 18.3% in Zip Code 06902 over the last two years to \$2929 per month while Zip Code 06905 was up 13.5% to \$2746. Be careful blaming Covid. Woefully low new home construction predates Covid. According to the US Census, Connecticut's population grew at an anemic 0.9% between 2010-2020 ranking CT dead last among all states.

This housing shortage directly hits lower income renters the hardest. Unfortunately the least among us are no match for organized NIMBYs who are usually older, wealthier, privileged property owners. Working class people are busy working and taking care of their families. They don't have the luxury of time and resources that opponents of development have. While housing advocates fight for low-income renters it is the Board of Representatives that is sometimes their last line of defense. It can be argued that by design the Board has limited opportunities to discuss specific housing projects. In the areas that it does have authority it has a weak housing record

this calendar year. The Board overturned the text change that would have made it easier to convert office to residential (clean up) and allow residential in office parks (CD District text).

Building more affordable homes is fundamentally about fairness. How can the Board in good conscience accept that our working class live in substandard and overcrowded housing, pay an obscene percentage of monthly income on housing, or commute long distances? Let's not forget that these workers teach our children, keep our hospitals open, and serve as first responders. We rely on them. Let's not forget them now.

Our Governor and our Mayor and their respective Administrations are continually selling Connecticut and Stamford to dynamic local employers and prospective out of state businesses. Bring your good, high paying jobs to Connecticut, they say. While State tax subsidies are a lure in these negotiations, CEOs need to know that the community is affordable for their workers. The burden on every public servant is to figure out where to house these workers. Denying them housing is public servant malpractice. Stamford and Connecticut need to continue to grow and thrive. Our community relies on our collective ability to grow. The load is lighter for all when we all help carry the burden.
