Hello,

I wanted an opportunity to express my support for keeping the Glenbrook Community Center open. The people of Springdale and Glenbrook share a great sense of community. Our neighborhood is a place for which we care deeply, are proud of, and strive to maintain what we love about living here.

Prior to Covid, this center was well-used and well-loved by this community. There is no other such site in this area and its absence in the last couple of years has been keenly felt and has left a hole for which there is no present solution. I would ask that you please reconsider the decision to sell and instead, allow the center to be reopened for its original purpose.

Too often, the City of Stamford has been dismissive of the concerns of our neighborhoods. When we have raised issues in relation to the continued building of apartments in our area and the detrimental effect on traffic and parking, we've been met with an unsympathetic reception and unkind names (NIMBY) implied or outright stated on social media sites associated with city concerns. This is both disappointing and somewhat lacking in respect.

We worry about things like our safety and that of our children on Hope St. I've had near misses there and have personally witnessed school children attempting to enter or exit the bus or commuters in crosswalks nearly meeting with a bad end due to drivers' impatience attempting to navigate the intense congestion and subsequent delays. My work commute takes me up the Merritt to Norwalk. The longest part of that journey is often Hope St. On many occasions, it's taken me over 20 minutes to travel from Woodway to Hartford Ave, a distance of less than 2 miles.

Our concerns are legitimate and deserve consideration. We too are your constituents and are worthy of being heard in an unbiased manner.

My name is Vince Massa and I am the Pastor of Landmark Baptist Church in Stamford. I am writing this letter in regard to the upcoming vote about the Glenbrook Community Center and the possible decision to turn it into affordable housing.

Thirty-nine years ago my wife and I moved to Stamford and began Landmark Baptist Church. I am the founder of our church and as I mentioned, and since its beginning have been the Pastor. Our first service in November of 1983 was held at the Glenbrook Community Center. For the first 2 or 3 years of our church's existence, we held our services there. In September of 2001 we purchased and renovated the property at 66 Crescent Street, where we are currently located. The Lord brought us back to the same street where we originally began. Since our return to Crescent Street, we had continued to use the Glenbrook Community Center for our Children's Ministries when we needed more space. And if the Glenbrook Community Center was still open for use we would rent the gymnasium for a Wednesday Night Children's program.

I am well acquainted with the various meetings and services the Glenbrook Community Center has provided the community of Glenbrook, Springdale, and the Cove areas of Stamford through the years. Some included DayCares, after-school programs, AA Meetings, classes and instruction, space for religious services, and more. While I recognize the need for low-income housing in Stamford, I and our church congregation feel it would be a disservice to the people of our community to not allow the Glenbrook Community Center to remain as it was. Our city needs to offer more than a place for businesses and housing, it needs to be a place where families and individuals can share, develop and grow common interests regarding family, work, identity, recreation etc. Stamford needs to be more community oriented.

Therefore, I am asking that on Thursday, September 29th when an official vote takes place regarding the Glenbrook Community Center's future it might be determined by the Committee to keep the Glenbrook Community Center open as it has been, a complete center for Community activities in Glenbrook.

Thank you for taking the time to consider my voice and opinion regarding this matter.
