Hello All,

I thank you in advance for taking the time to read this email.

I have been a life long Stamford resident, my husband and I own a house in Stamford, and my two sons attend Stamford Public Schools. I am invested in this City.

I grew up in Glenbrook and attended nursery school at the Glenbrook Community Center and also dance class in the Glenbrook Community Center. I always remember the Glenbrook Community Center as being happy place for kids to go afterschool as well.

The reason for this email is to urge you not to sell the center for housing development even if there is a certain square footage that would be designated as a community center.

- 1) Where will kids in that part of town and other parts of town go afterschool? Roscco (an afterschool program offered only at some schools) is not always an option for families. If we give more options to families and create a safe place for kids to go afterschool to learn something that is not academic, socialize with other kids, play and interact, then we will have better young citizens and less crime and more social emotionally balanced kids. Surrounding towns have many quality options for children to be involved in afterschool. We want the children of Stamford to have a place to go so they feel a sense of belonging, learn new things, socialize in a healthy way, and feel mental stability regardless of their homelife status. We, as a City, need to attract families to purchase dwellings in our City.
- 2) Where will the water supply come from? With the amount of residents in Stamford, water demand, and housing developments, will we (as a City) be able to sustain our water supply during all seasons? The summer months are the toughest historically and with more residents the water demand will be even greater.
- 3) It already takes me on most days to travel from my house in North Stamford to downtown Stamford about 30 minutes and sometimes more. Traveling home is longer. The roads are not in the best shape and the amount of people on the road is not safe. Adding more housing and residents will in turn create more wear and tear on our roadways, thus making driving unsafe in addition to more vehicles on the road—even if these residents travel by train for work. Dear Board of Representatives:

I am under the assumption that the BOR is set up, in part, to help constituents in a given district have a voice in situations that have a large impact on their communities.

Unfortunately, with respect to the Glenbrook Community Center, this does not appear to be the case. Not only have many of the local reps been silent on this issue, but it does not appear that much due diligence has been done by the Board. There are so many questions that need to be answered that the sale of the building to a developer should be rejected.

- A. Financial. The Mayor has been talking about a \$23 million price tag. At the recent GNA meeting a \$5 million renovation price tag was mentioned, and in a recent article someone who is familiar with the Center mentioned a price tag of less than two million dollars. Has anyone investigated the disparity in these numbers? And if the City is willing to spend \$2.5 million on a beer garden, why cannot it spend less than two million renovating a community center?
- B. Traffic and Parking. Has a traffic and parking study been done to look at the traffic impact of an additional 60+ vehicles in an already-congested section of Glenbrook? As for the parking, there are 44 one and two-bedroom apartments. If at least ¾ of the people have two cars, there is a need for a minimum of 73 parking spots. What about overflow parking when residents have friends and family over?
- C. Infrastructure. Have there been any studies as to how this new development will affect the electrical grid? What about sewerage, emergency services and schools? Recently there have been several new apartment buildings in the area, so there is already more pressure on the infrastructure and traffic.
- D. Lack of community space. The developer changed the specs last-minute to increase the amount of community space. However, a pre-school, a possible day-care center, and meeting and activity rooms will require more than 3,000 square feet. And will there be space for a playground for any of the children in the building? We can see that there will be little or no parking for community members who want to use the facility.
- E. Ramifications. Has anyone looked at the precedent set by this development? Is a densely packed, four-story structure without sufficient parking becoming the norm in residential communities? I have heard that the church property on Hope and Howes is up for sale. Is this the type of development we can expect for this large property? Also, what happens if the developer decides to sell? Lately we have seen building purchases after which the new owners raise the rents.
- F. Post-Covid considerations. From what I have read, the original RFP was presented during Covid and included a commitment for affordable housing units. Did anyone try to expand the RFP search post-Covid and exclude the housing commitment? The Glenbrook Community Center is a unique structure in Stamford and was, and should continue to be, the heart of the community.

It will be a devastating loss for the community and for the city if it is destroyed for the sake of an apartment building. This is not an opposition to affordable housing; this is an opposition to the destruction of the Community Center. If the City were to expend as much effort in revitalizing the center as it is in destroying it, the Center would be a valued and thriving place for all.

And for the record, the Glenbrook community is not a hot-bed of racism nor full of abhorrent residents. The community is only trying to keep the 50-year tradition of the Community Center alive and continuing for future generations of Glenbrook residents. It is a sad commentary when city officials place the enrichment of wealthy developers over the best interests and quality of life of the residents whom they are supposed to represent.
