**SUMMARY OF PROPOSED ORDINANCE  
AMENDING CHAPTER 6 OF THE CODE OF ORDINANCES,  
AUTHORITIES, BOARD, AND COMMISSIONS, ARTICLE XVII,  
STAMFORD APPOINTMENTS COMMISSION, SECTION 6-122 -  
MEMBERSHIP OF THE COMMISSION**

This ordinance amends the City of Stamford Code of Ordinances Chapter 6, Article XVII, Stamford Appointments Commission, Sec. 6-122, Membership of the Commission to provide that the two members of the Appointments Commission will be full voting members rather than ex officio members.

**SUMMARY OF PROPOSED ORDINANCE  
AMENDING SECTIONS 37-1 AND 47-37**

This ordinance amends the City of Stamford Code of Ordinances Sections 37-1 and 47-37 to make Section 37-1 consistent with Section 47-37 and clarify that if June 19th falls on a Saturday, the Juneteenth holiday shall be celebrated on the preceding day and if the 19th of June falls on a Sunday, the Juneteenth holiday shall be celebrated on the following Monday. The ordinance also corrects a scrivener's error in Section 47-37 which refers to an agreement that is not referenced in the Code.
