**REGARDING COMPENSATION OF ACTING MAYOR UNDER CHARTER
SEC. C3-10-4, TEMPORARY ABSENCE OR DISABILITY OF THE
MAYOR**

This ordinance provides that, under the authority of the Board of Representatives as set forth in Section C3-10-4 of the Charter, any member of the Board of Representatives exercising the power of the Mayor for a period of 48 hours or more due to the absence or temporary disability of the Mayor shall be compensated in an amount equal to the per diem salary of the Mayor from the time the member commences service as Acting Mayor until the date upon which such service terminates.
