**SUMMARY OF PROPOSED ORDINANCE
Amending Section 137-2(A) and 137-13 of the Code of Ordinances
regarding the Placement and Removal of Refuse and Recyclable
Containers from the Street and/or Curb.**

This ordinance amends Chapter 137, Garbage, Rubbish and Refuse, Article I, Section 137-2, Responsibility for Collection, to require refuse and recyclable containers for municipal collection be placed on the street or curb no earlier than the day before the collection day and be removed within 2 days of the collection. This ordinance also amends Section 137-13, Violations and Penalties, to provide that it may be enforced through the civil citation process. The ordinance is to take effect upon enactment.

**SUMMARY OF PROPOSED ORDINANCE
Amending Section 214-30 of the Code of Ordinances Regarding
Excavation Bond Requirements.**

This ordinance amends Chapter 214, Streets and Sidewalks, Article II, Encroachments and Excavations, Section 214-30, Excavation Bond Requirements, to change the requirement for an excavation bond from a one year bond to a two year bond.

**SUMMARY OF PROPOSED ORDINANCE
Amending Section 214, Article II of the Code of Ordinances.**

This ordinance amends Chapter 214, Streets and Sidewalks, Article II, Encroachments and Excavations, to remove specific violation and penalty provisions from the specific sections and add a general violation and penalty provision for the entire article to provide that each violation of the article shall be subject to a fine of not less than twenty-five dollars (\$25.) nor more than ninety dollars (\$90.) for each offense, and to provide that the Article may be enforced through the civil citation process.
