**SUMMARY OF PROPOSED ORDINANCE
AMENDMENT OF SECTION 214-14 AND SECTION 214-19 OF
THE CODE OF ORDINANCES TO INCREASE THE PERMIT FEE AND
DECREASE THE TIME PERIOD FOR SUCH PERMIT**

This ordinance amends Chapter 214, Streets and Sidewalks, Article III; Encroachments and Excavations, Section 214-14, Obstructions prohibited; safe passage, and Section 214-19, Permit for placing building materials on streets as follows:

- a) to increase the permit fee for occupancy of a street and/or sidewalk for construction materials from \$100 to \$200 and reduce the duration of such permit from 90 days to 4 weeks;
- b) to require the payment of an additional \$50 per day for each day the sidewalk is closed beginning with the 5th day of construction or \$50 per week if the sidewalk is partially obstructed but permits public travel;
- (c) to require payment of the following daily fees in the event any portion of a City street is closed or partially obstructed:

Street Designation (as provided by the Director of Operations)	Daily Fee per lane per day
Local	\$100
Collector	\$200
Minor Arterial	\$300
Major Arterial	\$400

- d) Notwithstanding the foregoing, if the entity requesting a sidewalk or street closure or causing an obstruction is a public utility regulated by the State of Connecticut Public Utilities Authority (PURA), the permit fee charged shall be \$200 for each period of 4 weeks.
- e) If the entity requesting a sidewalk or street closure or causing an obstruction has filed an application(s) for a Building Permit(s) for work related to the requested sidewalk or street closure permit in an aggregate amount no greater than \$30,000, the permit fee charged pursuant to this Section 214-19 shall be \$200 for each period of 4 weeks with no additional fees; and
- f) If the Stamford Police or other authorized government agent require additional street lanes to be closed beyond those specified in the permit, the permit fee shall be increased at a rate double the rates described above, to reflect the additional closures.
