#### SUMMARY OF PROPOSED ORDINANCE AMENDING CHAPTER 200, SECTION 200-33, CONCERNING THE RESPONSIBILITY FOR MAINTENANCE AND REPAIR OF SEWER LATERALS WITHIN THE CITY RIGHT OF WAY

This ordinance amends Chapter 200, Sewers, Article III, Water Pollution Control Authority; Use of System, Section 200-33, Building Laterals and Connections to specify that a) property owners shall bear responsibility for the maintenance of the sanitary sewer building lateral from the building to its connection to the public sanitary sewer system; b) property owners shall bear responsibility for repair of the of the sanitary sewer building lateral from the building to the property line; and c) the WPCA shall bear responsibility for repair of the sanitary sewer building lateral from the property line to its connection to the public sanitary sewer system, including the lateral line segments underneath the City right of way. The ordinance further provides that there shall be no reimbursement of costs incurred by property owners for maintenance or repair of the sanitary sewer building lateral on private property.
