## Valerie:

In response to item 3 below, the SWPCA doesn't have a record of the number or costs involved in lateral repairs over the last 5 to 10 years since the property owners have been responsible for the repairs in the past, and we were not involved. We know of a few lateral repairs that were brought to our attention where the property owner asked for assistance from the SWPCA Board. We estimate the costs for repairs to generally range from \$7,000 to \$10,000, but one repair that involved work on a major City street I believe was around \$30,000. We estimate that there may be as many as 10 to 15 lateral repairs a year.
