RESOLUTION NO. 3766 APPROVING FEE INCREASES FOR TERRY CONNERS ICE RINK

WHEREAS, it has been determined that it is in the best interests of the City of Stamford to review the Terry Connors Ice Rink fees charged by the City of Stamford.

WHEREAS, the Parks & Recreation Committee of the Board of Representatives held a public hearing on October 1, 2015, at which meeting it approved the following amendment to the current fee schedule.

NOW THEREFORE BE IT RESOLVED BY THE 29th BOARD OF REPRESENTATIVES of the City of Stamford, pursuant to and within the limitations of Sec. C2-10-2(6) of the Charter of the City of Stamford, that it does hereby approve the following fee amendment to the current Terry Connors Ice Rink ice rental fee schedule.

Ice Rental Rates

Category	Current	Proposed
Prime Time - Resident	\$420/hr	\$365/hr
Prime Time - Non-Resident	\$420/hr	\$430/hr
Non-Prime Time - Resident	\$350/hr	\$350/hr
Non-Prime Time – Non- Resident	\$350/hr	\$365/hr
Stamford Youth/School Groups*	\$280/hr	\$290/hr
Off season (April 1 – August 31)	\$300/hr	\$325/hr
Stamford Resident Adult evening group	\$291.67/hr	\$295.45/hr

*Youth Group Rate: In order to qualify for this rate all skaters must be under 18 years of age and the group must be a minimum of 50% Stamford resident. If not, you must pay \$440.00 per hour. This rate is not eligible for any residency discounts.

Non-Staff Skating Instructors***	No charge	\$5/session

*** Visiting instructors will be charged a flat fee to bring students to use the facility during freestyle, public and open hockey sessions


