WHEREAS, the Parks & Recreation Committee held a public hearing on March 26, 2015; and

WHEREAS, the 29th Board of Representatives determined that it is in the best interests of the City of Stamford to make the following changes to the City of Stamford beach pass fees at its April 6, 2015 regular board meeting.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Representatives of the City of Stamford, pursuant to and within the limitations of Sec. C2-10-2(6) of the Charter of the City of Stamford, does hereby approve the following fee schedule.
