RESOLUTION NO. 3742 NAMING THE FIELD AT 83 LOCKWOOD AVENUE AFTER ASSISTANT CHIEF OF POLICE FRANCIS CRONIN IN CONFORMANCE WITH SECTION 21 OF THE CODE OF ORDINANCES

WHEREAS, pursuant to Section 21-1 of the Code of Ordinances, the Board of Representatives has received a request from the Stamford East Side Partnership and the Domus Foundation to name the ball field at 83 Lockwood Avenue (at the corner of Frank Street and Maple Avenue) in memory of the late Assistant Chief of Police Francis Cronin: and

WHEREAS, Section 21-3.B of the Code of Ordinances provides that a city street, park or facility may be named to memorialize any person, inter alia, who has been deceased for more than six months prior to the request and contributed substantially to the establishment of such park or facilities or due to such person's contribution to the entire community; and

WHEREAS, Assistant Chief Francis Cronin passed away on March 25, 2011; and

WHEREAS, Assistant Chief Francis Cronin served the City of Stamford for 37 years, and was promoted to Assistant Chief in April, 2010; and

WHEREAS, Assistant Chief Francis Cronin played a significant part in transforming many neighborhoods in the City of Stamford, including the East Side, into the safe haven that they are today, and as stated by Police Chief Fontneau "was a passionate believer in advocating for youth and he personally touched the lives of many Stamford residents in a positive fashion."

NOW THEREFORE BE IT RESOLVED BY THE 29TH BOARD OF REPRESENTATIVES THAT

The ball field at 83 Lockwood Avenue be named the "Assistant Chief of Police Francis Cronin Field."

This resolution shall take effect upon its adoption.
